This course, which is offered under the auspices of the Jean Monnet Chair in External Economic Relations of the European Union (EUGLOBALECON), offers a comprehensive exploration of the economic policies, interactions, and relationships between the diverse regions of the Caucasus, Turkey, and the European Union (EU). The course provides students with a deeper understanding of the political and economic dynamics, challenges, and opportunities within these regions, focusing on the interplay between state institutions, economic policies, and societal factors. Students will delve into the economic landscape of the Caucasus, Turkey, and the EU, examining the factors that shape economic policies, trade relations, investment flows, and regional cooperation initiatives. The course provides a study of regional integration efforts within the Caucasus, Turkey, and the EU, including the EU's enlargement process, the European Neighbourhood Policy, and the Eurasian Economic Union. Students will analyse the economic and political implications of regional integration and the challenges associated with harmonising diverse national interests. Moreover, there will be discussions regarding the role of energy security, pipeline policies, and the geopolitical implications of energy dynamics in shaping economic relations. Lastly, an evaluation of the impact of conflicts, political instability, and security challenges on economic development and regional cooperation in the Caucasus, Turkey, and the EU will be held. Students will analyse the role of EU in peace-building efforts and

economic incentives in conflict resolution. This course will discuss a set of academic articles on the before-mentioned topics in-depth. Students are expected to read the articles for the seminar before class. The grade of the course will be determined by a seminar paper in the end of the semester.
