Development Economics: Globalization and the EU is a graduate course on development economics with a focus on EU economic relations with the Global South. It is offered under the auspices of the Jean Monnet Chair in External Economic Relations of the European Union held by Prof. Grigoriadis and his team. Within the context of EU policy decision-making, the first part of the course will concentrate on key models and approaches in development economics such as new growth models, inequality and poverty, population economics and rural-urban transitions, the role of resources such as land and labor and the impact of financial development through the lenses of credit markets and insurance modeling. Furthermore, we discuss theoretical and empirical topics in EU development policy with a strong focus on the political economy of foreign aid and international trade. Students are expected to become conversant with the analytical tools and theoretical discussions presented in the literature and related to EU development and trade policies. The role of the European Union as a global trade and development actor is central in the learning process. Political Economy of Europe is a graduate course on evolving role of government in promoting economic development, analyzed from the normative and from the policy aspects, with the focus on the EU and the EU-candidate countries. In the first part of the course the general arguments for government intervention in an economy will be presented and discussed, followed by the discussion on the role the institutions play is shaping economic development. The second part of the course is dealing with the economic and political aspects of government intervention in an economy, by discussing both the traditional functions of government (intervention in redistribution and provision of social security services – primarily pension and health insurance), as well as the new functions of government in promoting sustainable development (environmental economics). Finally, the third building block of the course will be dealing with sustainable financing of government intervention, by analyzing the topic related to economics of tax evasion, combining arguments provided by the neoclassical and behavioral economics. All topics will be presented from the normative perspective, taking into account economic and political aspects, as well as from the policy perspective in Europe and the impact of the respective policies in the EU on other countries, such as the EU candidate countries.

Active Participation: collective presentation (12 slides per person, 15 minutes per person) in the last five weeks of the semester.

Regular Participation: 75% attendance of seminars and lectures.
