

Aktuelle Themen der russischen Volkswirtschaft

In der Veranstaltung werden aktuelle Probleme vor allem der russischen Volkswirtschaft und - bei ausreichendem Interesse - auch der Volkswirtschaften anderer osteuropäischer Länder behandelt. Als Diskussionsgrundlage dienen vor allem neuere Arbeiten der russischen und westlichen wirtschaftswissenschaftlichen Literatur (vorwiegend in englischer Sprache) sowie die laufenden Studien der einschlägigen internationalen Organisationen, wie IMF, IBRD (Weltbank), OECD, EBRD.
